Signing this release affirms that I/we have adequate medical and liability insurance/protection, including self-insurance, and that the Producers will assume no responsibility for horse, rider or personal property. Losses occasioned by the injury or death of rider, spectator, or horse is agreed to be covered by the undersigned, including any insurance it may have, and it is further agreed that the undersigned, successors, assigns, heirs, representatives, dependents, or guests shall have no right or action against the Producers or any of their insurance carriers.

If the person is under 18 years of age, signature of a parent or legal guardian indicates acceptance of responsibility by said parent or legal guardian and release of liability of the Producers and affiliated persons.

If damage is caused by or to the undersigned's horse or horses, the undersigned takes full responsibility for damages to persons, property, or other horses and agrees to indemnify Producers against liability for such damages it may incur.
